Great Ormond Street Hospital marks the start of construction work

Tess Daly and Vernon Kay joined young patients at Great Ormond Street Hospital as they helped to launch the construction of the Premier Inn Clinical Building, an ambitious world-class facility which will form the second part of the Mittal Children's Medical Centre.

The couple, who are patrons for Great Ormond Street Hospital Children's Charity, were at the construction site of the new building, being delivered by Skanska, where they met young patients at the breaking ground ceremony last Tuesday (30 September).

The event marked the beginning of works that will see the top four floors of the hospital's outdated Cardiac Wing being demolished and redeveloped. As main contractor, Skanska will design, construct and fit-out the building, to provide 116 beds, a new surgery centre and a post-anaesthesia care unit.

The state-of-the art building, which will open in 2017, will also include a respiratory ward and a 16-bed isolation unit for children with dermatology and rheumatology conditions or infectious diseases. The new facilities will provide much needed space for a parent or carer to stay by their child's bedside overnight, more room for children to play and eat together, and areas for carers to have a break.

Once complete, it is anticipated that the entire hospital will be able to treat up to 20 per cent more children with the most complex, rare and often life-threatening conditions.

Thanks to their generosity, we will be able to fulfil our vision of providing world-class treatment in more comfortable and appropriate facilities suitable for patients and their families. Tess Daly who along with husband Vernon Kay has been a patron for the charity since 2007 said: "It's such an honour to be a part of this event. Hearing the huge difference the modern spacious wards can make to families going through such difficult times shows how important this day is."

About The Mittal Children's Medical Centre:

The Mittal Children's Medical Centre will comprise two buildings – the Morgan Stanley Clinical Building which opened in 2012 and the Premier Inn Clinical Building which will be completed in 2017. The two buildings will be connected floor by floor, allowing the most effective flow of patients and staff between similar facilities.

The Mittal Children's Medical Centre has a total budget of £321 million, of which £75m is being contributed by the NHS. The remaining amount is being funded through a combination of charitable and private support.

The Morgan Stanley Clinical Building (Phase 2A) was officially opened on 14 June 2012. It houses modern inpatient wards for children with acute and chronic conditions, including state of the art heart and lung, neurosciences and kidney centres. It also contains world class operating theatres, enhanced diagnostic facilities and a new restaurant for the whole site.

It houses many of the services that were previously located in the Southwood Building which opened in 1938.

Premier Inn Clinical Building (Phase 2B) the new Premier Inn Clinical Building, due to open in 2017 will see the top four floors of the hospital's outdated Cardiac Wing demolished and redeveloped.
