**Skanska's Co-COO Joey Hatch Adds Georgia Operations to Duties;
John Reyhan Appointed Georgia Area General Manager**

As Georgia's Area General Manager, Reyhan will provide day-to-day management of the office operations and help drive the company's momentum forward throughout the state. His construction expertise focuses on government and higher education facilities.

Recently, Reyhan led Skanska's Diversity Committee in Atlanta and serves on the board of the Hispanic Contractors Association of Georgia (HCAG). He holds a Bachelor's degree in management from the University of Illinois.
