### **Skanska Hires Two Alumni To Helm Aviation Center Of Excellence**

New York – Skanska USA Inc's building business unit today announced it has hired two alumni of the company to bolster its already-strong experience in aviation construction. One of these hires will be based in Chicago, where Skanska will begin to build a presence.

Jim Clemens returns to Skanska as executive vice president and general manager. In this role, he will lead Skanska's Aviation Center of Excellence (COE), pursuing and executing aviation projects across the country. Formerly a senior vice president with Skanska, Clemens has more than 30 years of experience in the industry.

Clemens will be based in a new Chicago office for Skanska. In addition to his Aviation COE responsibilities, he will work to further build Skanska's presence in the Midwest.

Also hired back to Skanska is MacAdam Glinn, who will support the Aviation COE as vice president for business development based in the company's Ft. Lauderdale office. Glinn held a similar role with Skanska before leaving to finish a law degree. Most recently, he served as senior manager for business development with Parsons, where he focused mainly on aviation.

Skanska has an impressive portfolio of work in the aviation industry. It completed the world's first LEED®-certified airline terminal with Boston Logan's Terminal A and has been active with work at major airports in New York City and Ft. Lauderdale, F.L., as well as at regional airports in Providence, R.I., and Kalamazoo, M.I.

"With many airports nationwide in need of updates to support new security measures, more passengers and the ability to add capacity, this is the right time to strengthen our aviation team," said Skanska USA Building President & CEO Bill Flemming. "By establishing a presence in Chicago, we not only position ourselves well within the aviation industry, but we expand our overall reach to

include another critical population center in the Midwest that complements our existing offices in Ohio and Michigan.”
