## Skanska Names Mike McNally President and CEO of Skanska USA Building

PARSIPPANY, NJ – September 24, 2007 — Skanska announces the appointment of Mike McNally as the new President of its business unit, Skanska USA Building, based in Parsippany, New Jersey.

McNally will assume his duties on October 1 of this year and will be based in the New York metropolitan area. McNally joined Skanska in 1998 and has attained progressively higher levels of leadership responsibility during his tenure, culminating in serving as Co-Chief Operating Officer for the northeastern U.S. prior to his new appointment. Before Skanska, he served in senior management roles with Fluor Daniel, Inc., Greenville, South Carolina and Marshall Contractors, Rumford, Rhode Island. McNally holds a B.S. degree in Civil Engineering from the University of Notre Dame, South Bend, Indiana, and an M.B.A. from the University of Rhode Island, Kingston, Rhode Island.

"Mike has played an important role in the restructuring undertaken within USA Building in recent years. Today, the unit is reporting strongly improved earnings and rising margins," says Stuart Graham, Skanska's President and CEO. "Consequently, the time is right for Mike to take over as President and for Johan to continue work with developing and coordinating our combined operations in the US."
