Datacert to Move Corporate Headquarters to 3009 Post Oak Boulevard Skanska secures long-term lease at first commercial office development in Houston, a state-of-the-art, green facility

Houston, TX (January 16, 2013) – Skanska USA's commercial development business unit in Houston, TX and Datacert, Inc., the leading provider of enterprise legal management solutions, announced today that Datacert is the first tenant to lease space at 3009 Post Oak Boulevard.

Skanska USA Commercial Development acquired the site in October of 2009 and is self-financing 100 percent of the development costs. The project is on track to deliver in Summer 2013 and is pre-certified LEED Platinum, the only speculative office building of this level outside the CBD in Houston.

Datacert is a 15-year-old, global company based in Houston that provides enterprise legal management solutions used by *Fortune* and *Fortune* Global 500 corporations and thousands of legal suppliers around the world. Datacert is relocating its corporate headquarters and will occupy 49,824-SF on the tenth and eleventh floors of the new building.

"Datacert has grown significantly over the past few years, increasing our workforce an average of 25% annually, and we're anticipating an additional 25% increase in 2013 as we expand our product portfolio and enter new strategic markets," said Alan Harding, chief financial officer, Datacert. "Our decision to move was driven by the need for more space to accommodate this growth, as well as a desire to have a state-of-the-art workspace that will help us attract and retain top talent and present well to our world-class client base. The innovative, green design of 3009 Post Oak Boulevard will provide our employees with an attractive work environment with lots of natural light that's in a premiere location near Houston's top amenities"

3009 Post Oak Boulevard, located in the premiere Uptown/Galleria submarket of Houston, will be a 20-story, 302,000-SF office building with 12 stories of office space sitting atop an 8-story parking garage. The building will feature an all glass curtain wall façade, an expansive double height ground floor lobby and 25,000 SF floor plates that maximize space planning efficiencies. The building skin and high efficiency mechanical and electrical systems are designed to reduce energy consumption by 25 percent for operational savings. In addition, the building will have a sophisticated lighting control system for the office and garage areas as well as a water-saving rainwater collection system used for landscape irrigation.

"We are seeing really strong activity in this tight market. It's very exciting to bring this sustainable property to an area that hasn't seen new Class A construction in nearly 30 years," said Mike Mair, executive vice president and regional manager of Skanska USA Commercial Development in Houston. "We are thrilled to welcome a premiere organization like Datacert to what will surely be a great showpiece for the Uptown/Galleria market."
