Skanska/JCB Project Named Outstanding Owner/User Building by NAIOP Central Florida Chapter

Orlando, Fla. – Skanska USA Building Inc. announced today that the Orlando Utilities Commission (OUC) Reliable Plaza project has been named the 2008 Outstanding Owner/User Building by NAIOP, the Commercial Real Estate Development Association's Central Florida Chapter.

"The OUC Reliable Plaza is known as the 'Greenest Building Downtown," said NAIOP Central Florida Executive Director Shannon Miller. "The plaza was officially unveiled on Veteran's Day 2008 and Skanska/JCB did a wonderful job with this project."

Skanska, in joint venture with JCB Construction, provided construction management services for this project, now housing OUC offices for administration, marketing, customer services, information technology, facilities and financial services departments.

The building is approximately 300,000 square feet. The conditioned office space is comprised of 167,000 square feet plus a 133,000-square-foot parking structure. The parking structure accommodates 370 parking stalls with an additional 30 stalls provided onsite. The 10-story building is comprised of a five-story office building on top of a five-story parking structure.

Some of the plaza's unique features include:

- A rooftop array of 144 solar photovoltaic panels that generate up to 32 kilowatt hours of electricity
- Four solar thermal panels to produce hot water
- High efficiency glass and daylight sensitive lighting
- Highly reflective roofing and covered parking to reduce heat absorption
- Raised flooring for more efficient cooling and heating
- A 30,000 gallon cistern to collect rainwater for onsite irrigation

The qualifications in the category Skanska and JCB Construction were recognized for include:

- Exceptional overall design to meet the needs of the owner/user
- Used quality materials with superior construction techniques
- Exhibits compatibility with its natural surroundings

- Technologically advanced
- Exceptional results achieved by all members of the development team

"We are humbled by the recognition bestowed upon our joint venture by NAIOP Central Florida," said Skanska Senior Vice President Randy Bernard. "I am especially proud of our Orlando Skanska team who spent countless and safety-conscious hours building a project that meets the Gold-level requirements for LEED® certification."
